GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:  									

**Report:**

On October 26, 2018, the Provincial Priest for the Capuchin Franciscan Order over the clergy of the Shrine of the Sacred Heart ("the reporting person") contacted the Child and Family Services Agency hotline in reference to a sexual abuse allegation. The Provincial reported that he received a letter signed by the mother of the complainant, herein referred to as Complainant #1, which stated that Urbano Vasquez, a local pastor of their church, Shrine of the Scared Heart, had sexually abused Complainant #1. The reported abuse occurred in approximately May of 2015.

**Investigation:**

On October 28, 2018, your affiant received the sexual abuse allegation assignment regarding Complainant #1 and Fr. Vasquez, herein referred to as the defendant.

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:									

Your affiant interviewed the reporting person. The reporting person stated that although he works at the central office in Pittsburgh, PA, he is responsible for the priests and pastors at the Washington, DC church the Shrine of the Sacred Heart.

The reporting person advised that he was in Washington, DC, on an unrelated matter when he was approached by the Head Pastor of the church, herein referred to as Witness #1. Witness #1 presented the reporting person with a letter signed by Complainant #1's mother and father. Witness #1 had written the letter in English based on his Spanish conversations with the Complainant #1's parents. The reporting person advised that the letter spoke of Complainant #1 being sexually abused by the defendant. He stated that he immediately contacted Sacred Heart's Child Protection Associate as well as the Child and Family Services Agency hotline.

The reporting person discontinued the defendant's ability to work, attend, or preach at the location, and advised him of the allegations made against him. The defendant denied these allegations to the reporting person.

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:									

On October 28, 2018, your affiant and another YFSD detective conducted an interview with Witness #1. Witness #1 stated that the defendant is an Associate Pastor at the parish and has been since 2014. Witness #1 reported that he is unsure of the exact date but stated that sometime around June-2015 or later, he was approached in the hallway of the rectory by Complainant #1's mother and the defendant. Complainant #1's mother advised Witness #1 that Complainant #1 disclosed to her that the defendant touched, or attempted to touch, her but she ran away. The defendant denied the allegation immediately.

Witness #1 said that it was evident that Complainant #1's mother had confronted the defendant prior to the two of them coming to him. Witness #1 stated that the conversation in the hallway lasted for several minutes and contained Complainant #1's mother accusing the defendant of touching Complainant #1 and the defendant denying the allegation. Witness #1 later told your affiant that when he asked the defendant about the allegation, the defendant stated to him that he only hugged Complainant #1 and nothing more.

<b>GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:</b>									

Witness #1 said that he offered to have the allegation reported to the church's Child Protection Associate but Complainant #1's mother "blew it off" and did not want to do anything. Witness #1 advised the church's Child Protection Associate about the allegation and that the family may be coming to her to make a report. He was unsure if the report was ever made.

Witness #1 supplied your affiant with two additional allegations against the defendant involving separate victims at this time.

On October 29, 2018, your affiant and another YFSD detective interviewed Complainant #1. Complainant #1 disclosed to your affiant that she was sexually abused by the defendant in May 2015. Complainant #1 said that she knows that it occurred in May 2015, on a weekend, and before her fourteenth birthday, which is in the middle of the month of May. She stated that she and her family were at the church for a cookout to sell food and to sell snow cones. Complainant #1 said that it was warm outside and she remembers wearing a skirt/dress and a spaghetti strapped shirt.

They went to the office of a worker at the rectory to wait for their mother. Complainant #1 reported that her brother lay on the floor and fell asleep while she sat on an office chair playing on her iPod.</p> <p>A short time later, the defendant came into the office and began talking to Complainant #1 about "general stuff." While speaking with her, the defendant stood over her shoulder while she sat in the chair. The defendant, while still talking to her, placed his hand on her chest and rubbed it down from her shoulder, under her shirt and bra, onto her breast. The defendant kept his hand on her breast and "caressed it." Complainant #1 turned the chair away from the defendant causing his hand to slide up from her breast to her upper chest/collarbone area. The defendant then quickly slid his hand back down onto her breast, continuing the same behavior.</p> </div>

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:										

The defendant finished his conversation, removed his hand from Complainant #1's breast and shirt, and left the office. Complainant #1 said that she sat in the chair, stunned, until she finally walked into the bathroom and cried. Complainant #1 said that she was in disbelief and did not know what to do. She called her friend, herein referred to as Witness #2, on her iPod from the bathroom. She told Witness #2 what occurred and Witness #2 told her to report the incident to her mother. Complainant #1 did not report it to her mother at that time. She then called two friends that were currently at the cookout and asked to see them. She met with the friends in front of the school and rectory and disclosed to Witness #3 what had occurred. They gave her the same advice as Witness #2.

Complainant #1 further reported that almost every Sunday, the defendant would grab her face with one hand and kiss her lips or side of the mouth and cheek.

<b>GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:</b>  									

The night of the abuse, Complainant #1 disclosed what occurred to her mother. She knows that her mother contacted Witness #1 at the church sometime thereafter.

Complainant #1 was presented with a single confirmation photograph depicting the defendant. Complainant #1 wrote that she knows the person depicted in the picture as "Padre Urbano." The photograph that was presented to Complainant #1 was retrieved directly from the Shrine of the Sacred Heart website that was labeled with the defendant's name. Furthermore, Complainant #1 stated that the photograph depicted the individual who had touched her.

On October 31, 2018, your affiant conducted an interview with Witness #2. Witness #2 recalled that Complainant #1 called her on the day of the incident. She stated that she received a video phone call from Complainant #1 and observed that she was crying. Complainant #1 told her that the Father/Priest of her church had touched her inappropriately, and later specified to her that the defendant touched Complainant #1's breast. Complainant #1 told her that she froze and did not know what to do. Witness #2 told her to tell her mother or someone who can do something.

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:											

Your affiant conducted an interview with Witness #3. Witness #3 was one of Complainant #1's friends at the church when the abuse occurred, but outside at the cookout. Witness #3 said that she was at the church's school, which is located across the street from the church and the rectory, when she received a phone call from Complainant #1. Complainant #1 said that she wanted to meet with her. Complainant #1 disclosed to her that she was in an office in the rectory when the defendant entered. Complainant #1 told her that the defendant touched her inappropriately and tried to kiss her. When asked if Complainant #1 described the inappropriate touching, Complainant #1 told her that the defendant touched her chest area.

Witness #3 further reported that Complainant #1 had spoken with her previously about how the defendant had tried to kiss her.

At the time of the offense, the complainant was 13-years-old and the defendant was 42-years-old.

Upon further investigation, your affiant obtained records related to two additional complainants.

Complainant #2's mother first reported an allegation to the church in approximately September, 2015 and again in approximately January, 2016. Complainant #2 disclosed that while in the dining area of the rectory of The Shrine of the Sacred Heart, her mother stepped out of the room to begin preparing the food. The defendant, who was in the dining area alone with Complainant #2 at this time, began talking to her and out of nowhere kissed Complainant #2 on her mouth. Complainant #2 described the kiss as open mouth and very sloppy.

Complainant #2 recalls that when her mother entered the room, the defendant stopped kissing her, and he pulled away from her. She then described a string of slobber coming from her mouth to his. While describing this detail, Complainant #2 began to cry.

Complainant #2's mother entered the room and observed the defendant kissing Complainant #2. The defendant pushed away from Complainant #2 and, when doing so, Complainant #2's mother observed a long string of spit/slobber coming from the defendant's mouth to Complainant #2's mouth.

Complainant #2's mother confronted the defendant and he immediately apologized and said that he does not know what came over him. Complainant #2 and her mother both reported that the offense occurred in May of 2015.

At the time of the incident, Complainant #2 was 16-years-old and the defendant was 42-years-old.

Complainant #3 reported to the church that in May, 2015, she was giving confession to the defendant. Complainant #3 and the defendant were in the rectory, sitting in chairs directly across from one another. The defendant moved his chair close to Complainant #3 during the confession and, while receiving confession to her, the defendant placed his hand on her lower thigh, just above the knee.
