Dear Respondent,

You have been issued a Notice of Infraction by the Department of Buildings. The text of the Notice contains important language concerning your rights as well as a description of the observed violations and fine. I understand that an infraction can be intimidating and a fine may be a financial burden. As a result, the agency has programs to assist in resolving the Infraction and reduce your financial liability.

Our Deferred Enforcement Program allows respondents to provide proof of abatement and have their citation canceled if provided within a timely manner. Abatement just means fixing any of the problems described in the infraction. Emergency Infractions need to be corrected within one day while Routine Infractions need be corrected within 60 days to take advantage of the Deferred Enforcement program.

The Alternative Resolution Program allows respondents to resolve Infractions through settlement. This program has a team of dedicated professionals trained to assist individuals desiring to reduce or eliminate their financial liability in exchange for abatement of the citied infraction. The Alternative Resolution Team (ART) also takes into account mitigating and extenuating circumstances such as cost of abatement, supply chain difficulties, availability of contractors, and weather when determining an appropriate settlement.

Both of these programs rely on your correction/abatement of the problems described in the infraction. Our Abatement Portal makes reporting housing and property maintenance code violations easy and can be accessed at <a href="https://info.dob.dc.gov/contact/abatement-tracking-BJbZLthgw">https://info.dob.dc.gov/contact/abatement-tracking-BJbZLthgw</a>.

Hundreds of respondents have participated in these programs saving time and money while quickly resolving their Infractions. I highly encourage taking part and note that participation does not deprive you of your rights to a hearing before an Administrative Law Judge at the Office of Administrative Hearings. However, these programs often result in quicker resolution and lower fines than the OAH process.
