**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

This Affidavit, in support of an arrest warrant, is a summary of the investigation of the concluding offense. This Affidavit is not a verbatim record of interviews or statements, nor does it detail every step of the investigation or facts known to your Affiant; rather, this document provides an overview of the case in an attempt to establish probable cause that a particular offense was committed by the Defendant. Your Affiant in this matter is Detective Alfonso Matos, of the Metropolitan Police Department's Criminal Investigations Division, First District Detectives Unit (IDDU).

1. On June 23, 2022, at approximately 2137 hours, the Metropolitan Police Department First District Detectives' office received a phone call from 1101 3<sup>rd</sup> Street, SE Washington DC 20002 for a caller who stated that she found a mini camera set up inside her bathroom changing area where she and her daughter have been changing clothes. Det. Matos and Det. Heithoff received the notification and located the mini camera inside of the complainant's bathroom changing area. Complainant L.N. was phone-interviewed and stated that the mini camera did not belong to her or her mother, I.H. and that they are the sole occupants of the residence. When asked if she had any idea who may have placed the camera in her changing area, the Complainant L.N. stated, "Eddy." "Eddy" is a known construction and remodeling worker that they have known for over a year and was at their residence to remodel it. Complainant L.N. further stated that once the camera was located by Complainant L.N. inside their D.C. residence, she noticed "Eddy" was behaving anxious, refusing to make eye contact, and was sweating profusely. Complainant L.N. provided several pictures of "Eddy" from Facebook.

2. The hidden surveillance camera is a small black camera with a charging port and record video onto a removable memory card. The recordings appeared to be in response to movement detected by the camera. The contents of the surveillance camera's memory card were examined and reviewed by Detectives. The examination of the memory card contents revealed the initial following footage; in a video; "Eddy" is clearly seen setting up the camera in the changing area, searching for underwear and ultimately

sniffing it (video last approximately 2 minutes and a few seconds). The next video Complainant L.N. wearing a long t-shirt and she is not wearing undergarments (video last approximately a minute). Both Complainants stated that "Eddy" did not have permission to install a surveillance camera in her house.

3. The following are photographs from the video on the memory card of EDDY setting up the surveillance camera:

Furthermore, the surveillance camera revealed the same surveillance camera was placed in the aforementioned bathroom changing area but inside of a vent (Picture 11).

7. The Suspect identified in this case, Eddy Danilo Giron (Latino Male with the date of birth 02/25/1981), has a valid Maryland State-issued Drivers License and the address listed is 2007 Quebec Street, Hyattsville, Prince George's County, Maryland 20783.

8. On August 02, 2022, a search warrant was executed in Prince George's county, Maryland, at the suspect's residence. The search yielded the following seizures: A 2011 Chevrolet van bearing MD tags: 7EB0427, two laptops, a sport camera, a small surveillance camera, an I-pad, Suspect's cellphone and a SD card adapter.

9. While on scene Det. Matos asked the suspect for his cellphone, password and he provided it and stated in Spanish, "Por favor no mires mi telephone al frente de my familia," which translate to English; please do not look in my phone in front of my family."

10. Note that all of the electronic devices seized are in the possession of the Metropolitan Police Department in Washington, D.C. at this time.

11. On September 14, 2022. Detective Gargac attempted to do an extraction on the iPhone associated with this case. It was discovered that the phone was factory reset post-offense, thus nothing of note is on it.

12. On September 14, 2022. Detective Gargac executed a search warrant(2022CSWSLD3247) on the HP laptop obtained by Det. Matos and Signed by DC Superior Court judge Iscoe on September 09, 2022. The search yield negative result and nothing of value was located on it.

13. In addition, a search warrant (2022CSWSLD3246) was executed on the Dell laptop obtained by Det. Matos and Signed by DC Superior Court judge Iscoe on September 09, 2022. The search yield negative result due to the laptop's operational system not working.

Based on the above facts and circumstances, your affiant requests that a District of Columbia Superior Court issued arrest warrant for Eddy Danilo Giron with the date of birth 02/25/1981 and MD permit G651169135146.
