#### GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:

1. On Saturday, January 7, 2023, at approximately 0356 hours, the Office of Unified Communications (OUC) received a 9-1-1 call for the report of a shooting. The caller reported that while in the 1000 block of Quincy Street, Northeast, Washington, DC, he shot a juvenile male who ran toward him. Members of the Metropolitan Police Department's (MPD) Fifth District and the District of Columbia Fire and Emergency Medical Services (DCFEMS) Ambulance 17 were dispatched to the scene. Responding personnel located the victim, 13-year-old K.B. (hereinafter, "decedent"), in front of in an unconscious and unresponsive state, suffering from apparent gunshot wounds to the body. The victim was transported by DCFEMS Ambulance 17 to Children's National Hospital at 111 Michigan Avenue, Northeast, where despite all lifesaving efforts, he was pronounced dead at 0439 hours by Dr. Hill. The decedent's remains were ultimately transported to the Office of the Chief Medical Examiner for the District of Columbia (OCME-DC), where a post-mortem examination was performed to determine cause and manner of death. Dr. K. Golden conducted the examination, and at its conclusion, determined the decedent's death was caused by multiple gunshot wounds to the body, and ruled the manner a homicide.

2. The shooting occurred in the 1000 block of Quincy Street, Northeast. The block is a residential area comprised of townhomes on the south end of the street, and single-family homes and a business on the north end. Courtyards enclosed by brick walls with security gates are on the front of the townhomes. The townhomes are fourstory condominiums: the top two floors are one residence and the bottom two floors are a different residence. The decedent was located on a mulched area just west and in front of Three casings were recovered from the scene. A black Smith and Wesson M&P .40 caliber semi-automatic pistol was located on the concrete entranceway to A single .40 caliber casing was located on the mulched area to the east of the sidewalk leading to A single .40 caliber casing was located within a courtyard area along the entranceway to Another single .40 caliber casing was located in the northeast corner of this courtvard area. 3. An alley traverses south from the area just east of Dark colored broken glass was observed in this alley near the west curb, and in close proximity to the alley's entrance/exit to the 1000 block of Quincy Street, Northeast. A gray Kia Sportage bearing Maryland registration of within this alley, in close proximity to where the alley begins to traverse east-west, and in the rear of 3 The vehicle was found stationary, but in the reverse gear. The front passenger side door was damaged and bent forward toward the right front fender. The driver door was open. Both rear passenger windows were shattered, and dark glass was observed in the rear portion of the vehicle. A defect, potentially made by a projectile, was located on the upper right portion of the left (driver's-side) rear passenger door in the C-pillar. A

small projectile was ultimately recovered from the rear seat of this vehicle. An illuminated black flashlight was located in the alley between the Kia Sportage and the entrance/exit to the 1000 block of Quincy Street, Northeast.

- 4. A white Kia Soul bearing District of Columbia registration of Quincy Street, Northeast, in front of 1000 Quincy Street, Northeast. The driver window of this vehicle had been shattered. An Audi A8L bearing District of Columbia registration of was parked on the north side of the street, just east of the white Kia Soul. The driver window of this vehicle was also shattered. A white Cadillac XT6 bearing District of Columbia registration of was parked on the south side of the street, in front of The front passenger window had multiple circular strike marks.
- 5. Members of the MPD Homicide Branch were summoned to the scene, and they assumed investigative responsibility. Your Affiant spoke with Officer O. Jackson, who was the first responding MPD member on the scene, and ultimately reviewed his body worn camera footage. As Officer Jackson approached the scene, he observed an individual, ultimately identified as the defendant, Jason Michael LEWIS, performing chest compressions on the decedent. LEWIS informed the officer of the location of his firearm and informed the officer that the decedent had run toward his house, and that he had shot the decedent. LEWIS added that he had a concealed carry permit, which was verified through the MPD gun registration database. LEWIS informed the officers on scene that he resided at a residence on the south side of the 1000 block of Quincy Street, Northeast. While speaking to Officer JACKSON, LEWIS informed him that he had fired only twice.

- 6. LEWIS informed officers that he was standing in the entryway to his courtyard when the shooting occurred.

  LEWIS stated, "they was across the street." LEWIS added that he was laying in bed and heard some noises. LEWIS said he came downstairs, because he did not know if someone was trying to come into his home. LEWIS said after he fired his weapon, the decedent yelled, "I'm a kid, I'm a kid," and collapsed by

  LEWIS said he stepped back and called police. Officer Jackson asked LEWIS about a camera located on the external wall of LEWIS' property, and LEWIS responded that it was operable. Based on that camera's location and orientation, that camera appears to capture the sidewalk and street in front of LEWIS' property.
- 7. Upon request, LEWIS provided Officer Jackson with a phone, so Officer Jackson could view surveillance footage from a BLINK camera affixed to The footage that Officer Jackson observed did not appear to capture the shooting. Meanwhile, LEWIS reported that he had heard what sounded like someone was banging on something. LEWIS said he came downstairs and observed a car and "youngsters" in black. LEWIS reported he said, "Hey! What are y'all doing?" On Officer Jackson's body worn camera footage, LEWIS said the decedent ran "directly towards (exact words indiscernible)," and that he, LEWIS, was standing in the entryway to his courtyard. Officer Jackson, who continued to watch the BLINK camera footage from LEWIS' phone, informed MPD officials that there is no footage depicting the decedent coming onto LEWIS' property.
- 8. LEWIS reported that his fiancé called 9-1-1. Officer Jackson asked LEWIS if he was alright. LEWIS reported he did not know why the decedent ran toward him. Officer Jackson asked LEWIS how far the decedent

got to his property. LEWIS reported the decedent got to the front of his gate. LEWIS said he was standing within his gate by the courtyard when he fired at the decedent.

Officer Jackson spoke with Fifth District detectives. Officer Jackson informed the detectives he viewed surveillance footage that depicts LEWIS exit his gate with a firearm. Officer Jackson advised that the footage he

observed did not capture the shooting, or anything additional, to include the decedent running toward the property.

Officer Jackson asked LEWIS to explain again how the event transpired. LEWIS reported he was in bed and heard a noise. LEWIS retrieved his firearm. LEWIS thought someone might be at his door. LEWIS walked out to his courtyard/patio area to the gate, which was unlocked. LEWIS observed the decedent by a white vehicle

(Kia Soul) parked on the north side of the street. LEWIS reported he yelled, "Hey" to the decedent, and the decedent

ran straight ("bee-lined") toward him in a full sprint to the front of his gate. LEWIS said he remained at his gate,

and then fired. LEWIS reported he did not want to harm the decedent and questioned why the decedent ran right

toward him.

11. Your Affiant spoke briefly with LEWIS on the scene. The detective requested that LEWIS respond to his

office to provide a statement. LEWIS agreed to do so and was provided with transportation to the Homicide Branch

by other detectives. While at the Homicide Branch, a detective informed LEWIS that he was not under arrest; Lewis

was provided Miranda warnings. LEWIS told the detectives that he wished to consult with an attorney.

- 12. Detectives located, identified and interviewed an individual, hereinafter referred to as Witness-1 (W-1). This witness reported that LEWIS came home late from work while IT was asleep. W-1 reported that LEWIS heard a noise and went down to investigate. W-1 said IT looked outside from IT's bedroom window (located on the second floor facing the 1000 block of Quincy Street, Northeast). W-1 observed an individual running toward IT's residence and one or two other individuals run to a vehicle parked in the alley. An individual was in the driver seat of this vehicle. W-1 reported IT heard two gunshots. W-1 said the vehicle backed away into the alley, almost leaving the other individual behind. W-1 reported LEWIS came inside and told IT to call 9-1-1. W-1 reported IT did so and provided the phone to LEWIS. W-1 observed LEWIS perform CPR on the decedent. W-1 reported that the individuals were black males, wearing black clothing. During the interview, W-1 received a phone call from an individual that IT identified as IT's attorney. W-1 reported the attorney was outside of the crime scene. W-1 said IT wanted the attorney with IT before IT answered any further questions. The person identified as the attorney was escorted to the residence and informed your Affiant that W-1 would not be answering any additional questions.
- 13. W-1 was interviewed on a second occasion with IT's attorney present. During the second interview, W-1 explained that it was not unusual for LEWIS to come home later into the night on Fridays. W-1 reported that LEWIS woke IT up and reported that he was going to check on noises. W-1 reported getting out of bed and going to the window that overlooks the 1000 block of Quincy Street, Northeast, and the patio area in front of IT's residence. W-1 reported that IT observed two individuals standing on the driver's side of LEWIS's vehicle—an Audi parked on the north side of the street. One of the individuals was standing by the driver door, while the other was by the rear left passenger side door. W-1 reported that IT could see a vehicle, which W-1 referred to as the

"getaway vehicle," was parked in the alley to the east of IT's residence. W-1 reported that IT saw LEWIS was at the gate in front of the residence and that LEWIS was looking at the "getaway car." W-1 reported that IT heard LEWIS shout, "Hey!" W-1 reported that the individual who was at the driver door looked over his right shoulder, and "jetted" toward "Jason." W-1 reported that at the same time, the second individual, who had been at the rear driver's-side door, looked over his left should and fled toward the alley, while the "getaway vehicle" began fleeing in reverse. W-1 reported that IT heard two gunshots. W-1 said IT believed the individuals were adults, and only heard the decedent was a juvenile when IT observed IT reported in the news. W-1 reported that the individual who "charged" at "Jason" got about five feet from him, and that is when IT heard the first shot. W-1 reported that after the shot the individual who ran at "Jason" continued running at him, there was a "pause," and then IT heard the second shot, at which time the individual who ran at "Jason" disappeared from IT's view behind the wall in front of IT's property.

- 14. The owners of the Kia Soul and the Cadillac provided detectives with written consent to search/process their vehicles for latent prints and DNA. LEWIS, who is the registered owner of the 2005 Audi with damage to the driver side window, refused to consent to the processing of his vehicle on the scene. The 2005 Audi A8L and the 2021 Kia Sportage were seized as evidence and towed by MPD crane to the DFS garage, pending the authorization of search warrants.
- Your Affiant determined that the 2021 Kia Sportage was reported stolen after 0900 hours on Saturday,
   January 7, 2023. Your Affiant spoke with the owner, hereinafter referred to as Witness-2 (W-2), who reported IT

On Saturday, January 7, 2023, at approximately 0830 hours, W-2 reported IT responded to the area where the vehicle had been parked and observed it missing. W-2 responded to the Fifth District to report the offense. W-2 reported there was no key left in the vehicle. While viewing the vehicle on the scene, detectives noted damage to the steering column and ignition.

- 16. Your Affiant located, identified and interviewed an individual, hereinafter referred to as Witness-3 (W-3).
  This witness reported IT had been asleep, but awoke when IT heard three to four gunshots. W-3 did not hear anything prior to the gunshots.
- 17. Your Affiant located, identified and interviewed an individual, hereinafter referred to as Witness-4 (W-4).

  This witness reported IT had heard two gunshots. W-4 did not hear anything prior to the gunshots.
- 18. Your Affiant located, identified, and interviewed an individual, hereinafter referred to as Witness-5 (W-5). W-5 reported IT was awake inside a residence in the 1000 block of Quincy Street, Northeast, during the early morning hours of Saturday, January 7, 2023. W-5 heard sounds coming from outside IT's residence. Witness-5 compared the noises IT heard to "a shovel scrapping against pavement." W-5 looked out from an upstairs window, which faces the alley south of the 1000 block of Quincy Street, Northeast, and overlooks the parking lot south of the 1000 block of Quincy Street, Northeast. W-5 added that IT looked outside because based on the noise IT heard, IT believed someone may be breaking into vehicles. W-5 did not see anyone when initially looking out of the

window. W-5 reported IT then heard a male voice yell, "Hey!" W-5 reported IT then heard a single gunshot. W-5 said IT is familiar with firearms. W-5 reported the gunshot was loud, and sounded like it came from a rifle. Within approximately five seconds, W-5 heard "three to five" more gunshots. W-5 advised the additional gunshots were not as loud as the first one. As soon as W-5 heard the final gunshot, W-5 heard an engine revving. W-5 next saw a vehicle traveling in reverse through the alley, possibly with its doors open, and then saw two juvenile individuals wearing black clothing flee from that vehicle through the alley by the PNC Bank, toward 12th Street, Northeast. W-5 reported IT called 9-1-1, and while on the phone with the call taker, observed lights from a police car. Upon observing the lights, W-5 heard what IT believed to be the same male voice that yelled, "Hey," state, "Over here." W-5 reported that another individual was in the residence with IT, and that individual estimated hearing six shots.

19. Your affiant viewed surveillance footage from a camera within the 1000 block of Quincy Street, Northeast. It should be noted the marked timestamp on the footage is approximately 15-16 minutes behind actual time (for clarity, the inaccurate timestamps noted below are what appears on the video). As previously noted in paragraph 3 of this affidavit, the Kia Sportage that was depicted parked in the alley directly to the east of sustained suspected bullet damage to the C-pillar on the driver side of the vehicle. Broken glass was located in the alley where this vehicle had been at the entrance/exit of the alley. As noted in paragraph 22, LEWIS' left arm is extended outward in the direction of this vehicle when a single gunshot is heard. As noted in paragraph 13, W-1 saw LEWIS looking at the getaway car when standing at the entrance to his property. As noted in paragraph 21, a flash, consistent with that originating from a firearm is depicted, originating from where LEWIS is depicted standing. Based on your affiant's training and experience, and review of the evidence, it is clear that LEWIS fired one shot at the Kia Sportage as one individual ran towards it. After LEWIS shoots the Kia Sportage located in the alley east of his property, approximately one second after this flash is depicted, then the decedent begins to run away from the Audi A8L. There were no other firearms recovered from this homicide scene. No firearms or weapons were recovered near or on the decedent's person. The only firearm recovered near the decedent's body was the firearm that LEWIS identified as belonging to LEWIS.
