PSA Santana and PSA Foy and I approached Ruff at Dorchester Street. We attempted to stop Ruff to issue him a citation for smoking on the boardwalk. As I approached Ruff, I ordered him to stop so we could issue the citation. Ruff ignored my commands and continued to walk away from the scene towards the 10-block of Dorchester Street. PSA Foy and I again ordered Ruff to stop but again he turned away and go around us. Ruff then turned around and walk back towards the boardwalk, where he continued to refuse our commands. I then proceeded to step in front of Ruff, while PSA Foy stood behind him in attempt for Ruff to stop eluding us. I attempted to detain Ruff while PSA Foy stood behind him holding his hands behind him.

PSA Foy and I informed Ruff that he was being detained. As PSA Foy and I attempted to put handcuffs on Ruff, he tensed his arms and did not comply. At this point Officer Adams (8600) arrived on scene and assisted PSA Foy and I in taking Ruff to the ground. As PSA Foy, OFC Adams and I ordered Ruff to place his hands behind his back multiple times OFC Adams grabbed Ruff around the waist and forced Ruff to the ground.

Once on the ground Ruff continued to resist and refused to place his hands behind his back. I then grabbed Ruff's feet, restraining them to the ground so Ruff could not kick me or other officers. Ruff was bracing his arms underneath his chest to prevent officers from handcuffing him. PSA Foy attempted to pull Ruff's arm from underneath him. PSA Foy placed his knee on Ruff's shoulder and was able to overcome Ruff's bracing and freed one arm. As PSA Foy was in the process of freeing Ruff's arm, Ruff rolled over to his left side. Ruff then looked back at OFC Adams, PSA Foy and I, and yelled that he would fight us and, "knock all you

out." As we attempted to pull Ruff's arms a male walking by on the boardwalk along with people on balconies of the Belmont Towers were yelling at Ruff to stop fighting the police and comply with commands. I observed these people to have looks of shock disgust on their faces when they heard Ruff shouting at us.

I observed Ruff grabbing OFC Adams' uniform shirt. OFC Adams pushed Ruff on his right side as PSA Foy place his right hand on the back of Ruff's neck. At this time, I continued to hold Ruff's feet to the ground. Once we were able to roll Ruff back over onto his stomach, Ruff continued to attempt to pull his arms under him as he resisted. PSA Foy was able to lock his arm and bend his hand towards his elbow, OFC Adams and I were able to secure Ruff's right arm behind his back, PSA Foy was able to secure Ruff's left arm hand his back, while OFC Adams handcuffed Ruff.

As PSA Foy, OFC Adams, and I lifted Ruff off the ground and Ordered him to walk towards the 10-block of Dorchester Street, Ruff continued to be non-compliant and actively resisting, pushing off the ground away from the street. We continued to assist Ruff towards the 10-block as he continued to thrash and throw his shoulders towards us. Once at the 10-block, Officer Mora (8385) and Officer Gonzalez (8611) grabbed Ruff's legs forcing him to sit on the curb.

I then observed Ruff stand up from the curb in attempt to run away from Officer. Panitch (8371) and OFC Mora. Once OFC Panitch and OFC Mora were able secure Ruff on ground I assisted by holding Ruff's legs to the ground. I then observed OFC Panitch use a Violent Person Restraint Device (VPRD) on Ruff.
